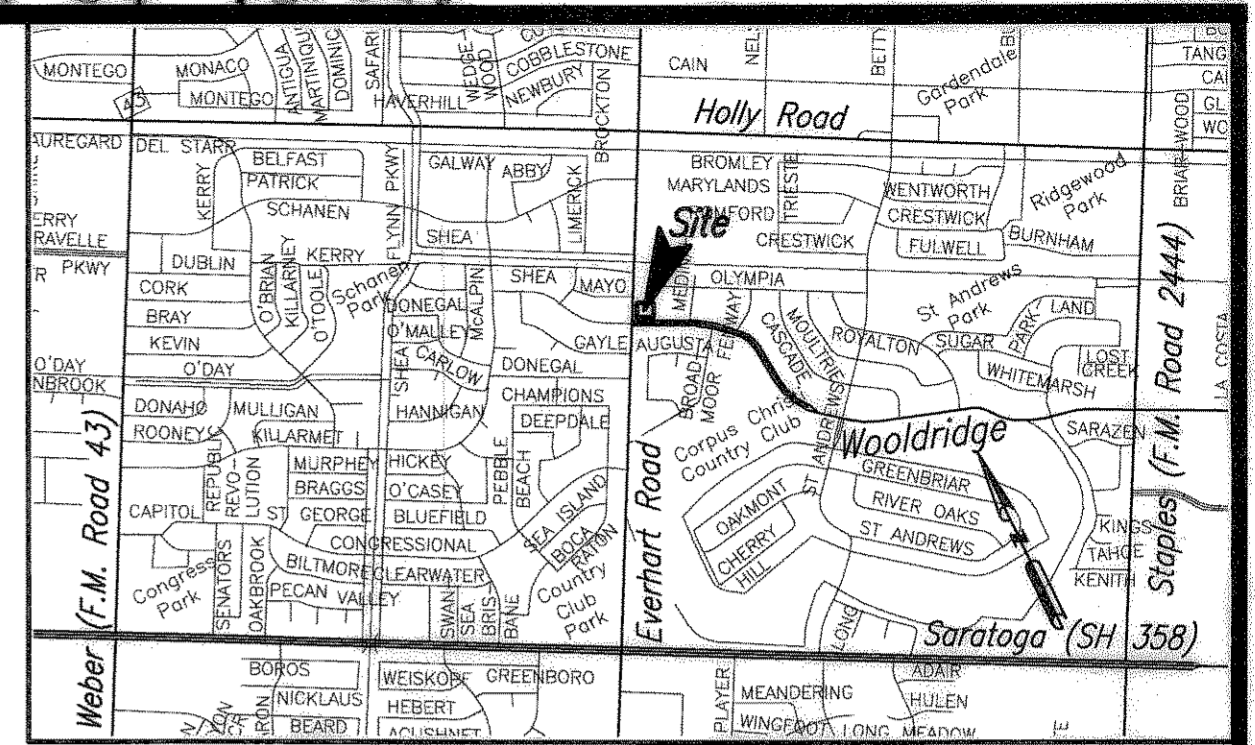
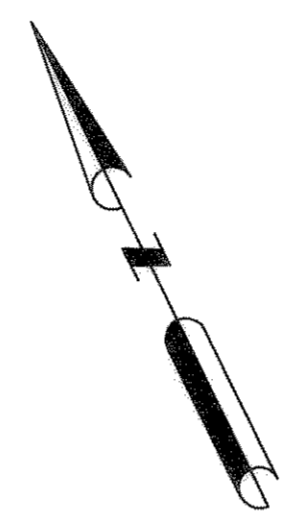


### Plat of Country Club Estates Unit 1 Block 3, Lot 2A

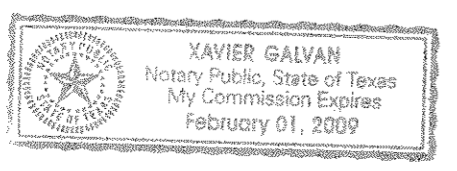

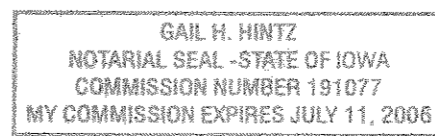

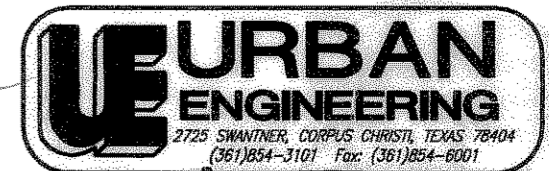
